RATE OL-1
OUTDOOR LIGHTING SERVICE

Availability

Available to all member/owners for dusk-to-dawn outdoor lighting in close proximity to existing overhead secondary circuits.

Rate per Light per Month

Light mounted on existing wooden pole with bracket attachment and connected to existing overhead secondary circuit.

Area Lighting

\$6.95 per month for each 100-watt Sodium Vapor Unit
\$7.75 per month for each 175-watt Mercury Vapor Unit
\$12.95 per month for each 400-watt Mercury Vapor Unit

Directional Lighting

\$13.00 per month for each 250-watt Sodium Vapor Directional Unit
\$15.75 per month for each 400-watt Sodium Vapor Directional Unit

Additional Monthly Charges

\$6.00 per month for each additional transformer (see #3 below).

Service Provisions

1. The Cooperative shall furnish, install, operate and maintain the outdoor lighting equipment, including lamp, luminaire, bracket attachment, and control device on an existing pole owned by the Cooperative. Connection shall be made so that power for operation of the light does not pass through the meter which is used to measure the member/owner's billed consumption. The light shall be installed at a location mutually agreeable to both the Cooperative and the member/owner.
2. Should the member/owner request a light at a location other than on an existing pole owned by the Cooperative, the member/owner shall pay a one-time fee for the installation of the necessary additional facilities. The charges for such facilities, i.e. pole and conductor, shall be in accordance with Regulation No. 21. All additional poles installed under this provision shall remain the property of the Cooperative.
3. Should the member/owner request a light at a location where a transformer must be provided for just the light, i.e. where there is not a metered service off of the transformer serving the light, there will be an additional charge of \$6.00 per month for

this transformer. This charge will be dropped if a metered service is added to the transformer or this charge will be added if a metered service is disconnected and the security light is left in service.

4. The Cooperative shall maintain the lighting equipment, including replacement of lamps or other components due to normal depreciation, consumption, or burnout, at no additional cost to the member/owner. Except during emergencies, any required maintenance work shall be done within 72 hours after the member/owner notifies the Cooperative of the need for maintenance of the lighting equipment. All maintenance work will be done only during regular working hours of the Cooperative.
5. The lighting equipment shall remain the property of the Cooperative. The member/owner shall protect the lighting equipment from deliberate damage. The Cooperative reserves the right to refuse replacement of a lighting unit or any component thereof that has been damaged by vandalism or willful destruction.
6. The member/owner shall allow authorized representatives of the Cooperative to enter upon the member/owner's premises and to trim trees and shrubs as may be necessary for maintenance of the lighting equipment and for removal of the lighting equipment upon termination of service under this schedule.
7. The Cooperative and the member/owner shall execute an agreement for service under this schedule for a period of not less than one year.
8. Mercury vapor lighting is provided on an "as available" basis. When mercury vapor equipment is no longer available, EIEC will replace the fixture with a suitable alternative, which a member may decline.

Utility Taxes

Any tax and fees levied on the Cooperative under the Illinois Public Utilities Revenue Act shall be added to the rates and minimum charges specified in this schedule. Any additional taxes that may be imposed by taxing authorities on the member/owner shall also be added to the above rates and minimum charges.

Terms of Payment

The above charges are net, the gross charges being 5 percent higher. In the event the current monthly bill is not paid within 15 days from the date of the bill, the gross charges shall apply.
